

CRRSAA FUNDS REPORT FOR STUDENT PORTION OF 18004(a)(1) Quarter ending 3/30/21 and FINAL

- Southwestern College signed and returned to the Department of Education the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50% of the funds received under Section 18004(a)(1) of the CRRSAA Act to provide Emergency Financial Aid Grants to Students.
- 2. Southwestern College received \$22,696 from the Department of Education for Emergency Financial Aid Grants to Students from the CRRSAA Act.
- 3. As of June 30, 2021, the total funds of \$22,696 had been granted to students as Emergency Financial Aid Grants under Section 18004(a)(1) of the CRRSAA Act.
- 4. The estimated total number of students who were eligible to receive Emergency Financial Aid Grants equals is 93.
- 5. The total number of students who received an Emergency Financial Aid Grant under the student portion of Section 18004(a)(1) of the CRRSAA Act is 26.
- 6. Responsibility for managing the application process was assigned to the Dean of the College. The Dean of the College used the same methodology developed for the CARES Act grants by a team of one student, one board member, one faculty member, and two staff members. The following method was used to determine which students received Emergency Financial Aid Grants and how much they received:
 - Every student who made a request and was enrolled for the Spring 2021 quarter received funding.
 - If the request was under \$1,000, it was funded at 100% of the requested amount.
 - If the request was \$1,000 or more, \$1,000 was granted.
- All students enrolled in Spring 2021 quarter were emailed information about the CCRSAA Act funds and how to apply for an emergency grant. (Appendix A, February 3, 2021 email to students)

Students applied for funds. (Appendix B, Application Form)

Students were notified they received a grant. (Appendix C, sample award notification email)

Review of Applications: Applications will be reviewed anonymously - the applicant's name will be removed before the committee reviews the application. The committee will include 4 people - one faculty member, one Board member, one student who will not be applying for funds, and one staff member.

Timeline: Applications will be reviewed by March 15, 2021. Students will receive an award letter by March 22nd and funds will be disbursed by April 1st.
